## Letter of Intent to Lease

- 1. Premises: Approximately **6,800 sq. ft.** of Industrial/Retail Space
- 2. Term: The term of the lease shall be for **Three** (3) years Commencing **May 1<sup>st</sup>**, 2025 and ending **April 30th 2028**.
- 3. Base rent: Base Rent of the lease shall be Ten Thousand Dollars (\$10,000) total gross modified plus utilities per month. Payable upon execution of Lease Agreement.
- 4. Security Deposit: The Security Deposit shall be Ten Thousand Dollars (\$10,000) Payable upon execution of Lease.
- 5. Move in Costs: Total amount due at execution of lease is Twenty Thousand Dollars (\$20,000)
- 6. Option to Extend: Extension of the original lease term may be adjusted through mutual agreement thereafter the lease term. Two year (2) year option to extend.
- 7. Condition of property: Lessor shall deliver the premises broom clean with all plumbing and electrical systems in good operating condition.
